

Highlights

Highlights in the second quarter of 2022

- Net profit was NOK 510.6 million.
 - **Earnings per share (EPS)** was NOK 0.79.
 - **EPRA NRV** was NOK 26.24 per share.
- **The rental income** of NOK 255.5 million showed a growth of NOK 26.9 million (11.8 per cent) compared with last year.
 - New leases with a total annual rental income of NOK 91 million were signed or extended.
 Expired leases totalled NOK 4 million, resulting in a substantial amount for net new leases of NOK 87 million.
 - **Annual rental income (run rate)** from the property portfolio has increased by NOK 16 million as a result of new and improved leases, and it was NOK 1,063 million at the end of the quarter.
- **Positive fair-value adjustments** for both investment properties and financial derivatives.
 - The fair-value adjustment of investment properties was positive at NOK 347.2 million (1.3 per cent), mainly related to a substantial reduction in vacancy at Fornebu. A new large and long-term lease at fair market rent levels with a public tenant at the company's properties at Fornebu led to an increase in the valuations from the independent appraisers.
 - The fair-value adjustment for financial derivatives excluding bilateral bonds was positive by NOK 56.1 million. Long-term market interest rates increased during the second quarter.
- **The joint venture residential company Nordr** increased its number of residential units under construction with 174 units this quarter and has 1,912 residential units under construction.
 - The construction started for a total of 493 units while a total of 312 residential units were delivered in the second quarter. A total of 1,071 units are expected to be delivered over the next five quarters.
 - The book value of the share in Nordr was NOK 1,136.2 million and the estimated fair value was NOK 2,260 million.
 - Norwegian Property's share of profit from Nordr in the second quarter was NOK 50.6 million.
- Several refinancing activities were completed in the second quarter.
 - Three new bilateral revolving credit facilities have been established and replaces facilities due in 2022. A term loan was also prolonged during the quarter.
 - The available unused credit facilities after the refinancing activities amount to NOK 2.1 billion.

Financial developments

Results

Operating revenue

The rental income from commercial properties amounted to NOK 255.5 million in the second quarter (NOK 228.6 million¹). Adjusted for new and divested properties (like-for-like revenue), this represented an increase of NOK 26.6 million from the same period of 2021. Rental income for the first half of 2022 totalled NOK 498 million (NOK 454.3 million), representing a like-for-like increase of NOK 42.6 million.

Retail and restaurant turnover at Aker Brygge in Oslo was up by 62 per cent for the second quarter from the same period of 2021, and up by 3 per cent from the pre-COVID-19 second quarter of 2019.

The change compared with last year in retail and restaurant turnover for Vinslottet at Hasle shows a similar increase of 28 per cent for the second quarter.

Operating costs

Property-related operational expenses totalled NOK 17.1 million (NOK 14.9 million) for the second quarter and NOK 33.1 million in the first half (NOK 31.2 million). Other property-related expenses came to NOK 11.5 million (NOK 14.8 million) for the quarter and NOK 28.6 million for the first half (NOK 29.9 million). Administrative expenses amounted to NOK 13.6 million (NOK 14.2 million) for the quarter and NOK 27.9 million in the first half (NOK 26.2 million).

Share of profit and loss from joint ventures

The table below presents a summary of Norwegian Property's share of profit and loss from joint ventures.

Nordr

Norwegian Property's share of the net profit relating to Nordr was NOK 50.6 million for the second quarter (NOK 47.2 million) and NOK 60.2 million for the first half year (NOK 55.6 million). Norwegian Property's share of net assets in the balance sheet as at 30 June was NOK 1,136.1 million. In accordance with the IFRS, income recognition from the sale of residential units is based on the completed contract method.

During the second quarter, sales agreements were entered into regarding 227 residential units. The construction started on 493 units. A total of 312 units were delivered, with 195 in Sweden and 117 in Norway, and Nordr has 1,192 units under construction as at 30 June.

As at 30 June, Nordr had a land bank of approximately 14,500 units in Norway and Sweden. The land bank is mainly located in the largest Norwegian and Swedish cities, with an emphasis on eastern Norway and the extended Stockholm capital region in Sweden.

The figure below shows the expected completions during the next five quarters based on the best estimate for the timing of the projects. A total of 1,071 residential units are expected to be completed during the next five quarters in both wholly and partly owned projects in Norway and Sweden.

Independent appraisers have valued all the plots in the company's portfolio, and there was a substantial increase in the valuations compared to the valuations at the time of the acquisition. The valuation uplift increased the NAV metrics for Norwegian Property but does not affect the book value of the investment.

Forusbeen 35

A joint venture for the property at Forusbeen 35 in Stavanger has been established in cooperation with the local residential developer Base Bolig. The property has been rezoned from a commercial building to a combined residential and commercial property. Until the construction begins, the operation of the property will continue as a commercial property.

Norwegian Property's share of the net profit/loss relating to Forusbeen 35 was negative at NOK 0.2 million for the second quarter (positive at NOK 0.1 million) and NOK 0.7 million for the first half year (NOK 0.2 million).

Operating profit before fair-value adjustments

Operating profit before fair-value adjustments amounted to NOK 263.7 million (NOK 231.9 million) for the second quarter and NOK 467.8 million in the first half (NOK 422.4 million).

Fair-value adjustments for investment property

The valuation of the property portfolio yielded a positive unrealised fair-value adjustment of NOK 347.2 million in the second quarter (NOK 65.8 million). The positive fair-value adjustment is mainly related to a substantial reduction of vacancy in the company's properties at Fornebu. At Fornebu a 15-year lease has been entered into for approximately 12,000 sq.m. with a public sector tenant at fair market rent levels. The total fair-value adjustment of NOK 347.2 million represents a 1.3 per cent change from the value as at

31 March and the cost of investments for the period. The total market value of the property portfolio as at 30 June 2022 amounted to NOK 26,210.1 million. The positive unrealised fair-value adjustment for the first half of 2022 totalled NOK 906.7 million (NOK 276.2 million).

Net financial items

Net realised financial expenses amounted to NOK 88.2 million for the second quarter (NOK 81.3 million) and NOK 173.6 million in the first half (NOK 163.1 million).

Long-term market interest rates increased during the second quarter. The positive fair-value adjustment for financial derivatives excluding bilateral bonds was NOK 56.1 million (negative change of NOK 8.9 million). The positive fair-value adjustment in the first half was NOK 179.2 million (NOK 87.4 million).

Profit for the period

Pre-tax profit amounted to NOK 578.8 million for the second quarter (NOK 207.5 million) and NOK 1,380.2 million in the first half (NOK 623 million). The income tax expense in the second quarter of NOK 68.2 million relates to non-payable deferred taxes (NOK 31.7 million) and NOK 233.4 million in the first half (NOK 112.5 million). Net profit in the second quarter was thereby NOK 510.6 million (NOK 175.8 million) and NOK 1,146.8 million in the first half (NOK 510.4 million).

Balance sheet

Total assets in the balance sheet as at 30 June were NOK 27,888.3 million (NOK 25,394.7 million), with investment properties accounting for NOK 25,849.9 million (NOK 23,573.8 million) and properties used by the owner accounting for NOK 112.1 million (NOK 100.5 million). Non-current receivables amounted to NOK 248.2 million, related to the rental guarantee provided by the seller of the property at Snarøyveien 30 (NOK 313.1 million).

Investment in joint ventures was NOK 1,136.2 million (NOK 1,048.8 million), and is in its entirety related to the investment in Nordr.

Norwegian Property held NOK 99 million in cash and cash equivalents (NOK 132.6 million).

Total interest-bearing liabilities in the balance sheet came to NOK 12,053.6 million (NOK 11,748.4 million), with non-current interest-bearing liabilities totalling NOK 9,580.5 million (NOK 10,721 million) and current

interest-bearing liabilities amounting to NOK 2,473.1 million (NOK 1,027.5 million).

Financial derivatives accounted for a net asset of NOK 152.4 million (net liability of NOK 89.7 million), with NOK 175.5 million classified as assets (NOK 11 million) and NOK 23.2 million as liabilities (NOK 100.7 million).

Equity totalled NOK 13,625.4 million (NOK 11,924.6 million), representing an equity ratio of 48.9 per cent (47 per cent). The book value of equity per share was NOK 21.17 (NOK 18.53). Outstanding shares totalled 649,825,596 (649,825,596). Treasury shares totalled 6,250,000, and 643,575,596 shares were held by the external shareholder.

Dividend

The board has resolved to pay a dividend of NOK 0.125 per share for the second quarter of 2022.

Cash flow

Net operational cash flow was NOK 86.2 million for the second quarter (NOK 16.7 million) and NOK 232.1 million in the first half (195.1 million). Cash earnings in the second quarter amounted to NOK 125.4 million. The change in other short-term items amounted to a negative amount of NOK 39.1 million.

Investments in fixed assets amounted to NOK 48 million for the second quarter (NOK 192 million), related to the adjustments for lessees associated with new and renegotiated leases and ongoing operational investments. Investments totalled NOK 142.1 million in the first half (NOK 248.2 million).

Net cash flow from financing activities was negative at NOK 80.8 million for the second quarter (positive at NOK 85.3 million), following a reduction of NOK 0.4 million in interest-bearing debt and a dividend of NOK 80.4 million. For the first half, net cash flow from financing activities was negative at NOK 304.8 million (NOK 480.1 million).

Cash and cash equivalents showed a reduction of NOK 42.6 million for the second quarter (NOK 90.1 million) and a reduction of NOK 214.6 million in the first half (NOK 533.2 million).

Interest-bearing liabilities

Interest-bearing liabilities totaled NOK 12,053.6 million as at 30 June (NOK 11,748.4 million). In addition, the company had undrawn credit and overdraft facilities of NOK 2,066.3 million (NOK 1,400 million).

Norwegian Property entered into three new bilateral credit facilities during the second quarter:

- SEB: NOK 615 million for 3 years
- Swedbank: NOK 595.3 million for 3 years
- DNB: NOK 680 million with annual renewal

In addition a Term Loan in SEB of NOK 530 million was prolonged with 1 year.

The NOK 374 million bond loan (NPRO 13), which matured in June, was refinanced with a withdrawal on a RCF in DNB and SEB.

The total amounts maturing in the second half of 2022 are bonds amounting to NOK 1,515 million. In addition NOK 600 million under a RCF is up for renewal. NOK 374 million is drawn under this facility as of 30 June 2022.

Market and operations

Commercial property market

Norwegian Property estimates the office vacancy rates in Oslo at 5.9 per cent overall, 4.5 per cent in the city centre and 7.7 per cent in Nydalen. Moderate vacancy rates in the past few years have contributed to positive trends for rents. Office vacancy at Fornebu is 15.4 per cent. The level of activity in the transaction market has been high for several years, with many properties changing hands in various segments at strong yield levels. The prime yield for the Oslo CBD is considered below 3.25 per cent.

Loan margins in the bond market have spread out in the second quarter, and bond investors seem to be reluctant to take on new risk.

The 10-year swap interest rate went from 2.8 per cent at the beginning of the quarter to 3.2 per cent at the end of the quarter. The central banks have hiked interest rates, both in European countries and in the US. Energy costs are still very high, and together with the shortage on goods and materials as a result of the war in Ukraine and the aftermath of the COVID-19 pandemic, the fear of inflation continues.

The property portfolio

Key figures

Norwegian Property owned 29 investment properties as at 30 June 2022. These are primarily located in the central areas of the Oslo region. The company's properties mainly comprise office premises as well as retail and restaurant space along with the associated warehousing and parking for the office areas.

Total ongoing annual rental income (run rate) from the company's whole property portfolio was NOK 1.063 billion as at 1 July 2022. That represented an increase of NOK 16 million since 1 April 2022. NOK 63 million of the run rate is related to the rental guarantee provided by the seller of the property at Snarøyveien 30. The overall financial vacancy in the property portfolio totalled 4.9 per cent, which is primarily related to the properties Sandakerveien 138-140 and Snarøyveien 36. The weighted average remaining duration of the leases was 5.3 years, and the average rent adjustment factor for the consumer price index was 99.9 per cent for the total portfolio.

The key figures above do not include space under construction as at 30 June 2022. Ongoing projects at the end of the quarter are specified in the table below.

New leases

New leases with a total annual rental income of NOK 33.8 million were awarded in the second quarter, while existing leases totalling NOK 57.2 million were extended. Expired leases totalled NOK 4.2 million. Therefore, the net increase in annual rents from leases during the second quarter was NOK 86.8 million.

Valuation of the property portfolio

Two independent appraisers have valued all the properties in the company's portfolio based on the same methods and principles applied in the previous periods. The accounting valuation as at 30 June 2022 is based on an average of the two valuations.

As at 30 June, the company's portfolio of investment properties was valued at NOK 26,210.1 million (NOK 23,987.4 million). The rent guarantee receivables and properties used by the owner were carried separately in the balance sheet at NOK 248.2 million and NOK 112.1 million, respectively, and recognised at fair value. Fair-value adjustments recognised in the profit and loss for the investment properties were positive at NOK 347.2 million for the second quarter. This represents a 1.3 per cent change from the value as at 31 March and the cost of investments for the period.

Shareholder information

As of 30 June 2022, the company has a share capital of NOK 324,912,798 divided into 649,825,596 shares, each with a par value of NOK 0.5. The company owns 6,250,000 treasury shares. Geveran Trading Co. Ltd. owns the remaining 643,575,596 shares in the company.

The environment and corporate social responsibility (CSR)

Norwegian Property has invited the public to Fornebu Summer Play in the outdoor areas next to Snarøyveien 30 and 36. Every Thursday to Sunday at 12-17 there are

activities, playground for kids and various food trucks serving food and drinks.

Risk and risk management

Norwegian Property assesses risk on an ongoing basis as part of the daily operations. A comprehensive annual review of the risks associated with the group is carried out in collaboration with all relevant levels of the organisation. Each risk factor is described and presented with possible negative outcomes. The analysis of risk factors includes the following main groups of risks.

- Financial risks such as the fair-value changes of investment properties, interest-rate risk and access to external capital.
- Credit risk such as the risk of losses on claims.
- Liquidity risk such as the risk associated with the refinancing of debt, access to external capital and the risk of delayed rent payments.
- Market risk such as changes in market rents, vacancy in the property portfolio, reduction in turnover based rents and the risk related to inflation.
- Project risk such as the uncertainty related to office vacancy, cost overruns, delays, accidents, demolition and recycling.
- Social and governance risk such as the risk related to human rights, decent working conditions, equality and non-discrimination among employees, non-discrimination of people with disabilities in properties and outdoor areas and corruption.
- Physical climate risk such as increased precipitation and higher sea levels.
 Climate transition risk - such as the demand for

- environment-friendly premises, environmental requirements from investors/banks, insurance, technological risk, reputational risk and increased CO₂ taxes.
- Risk associated with ongoing crises and events such as the effects of the COVID-19 pandemic and the war in Ukraine.

The latest description and analysis of risk and risk management is included on pages 104-118 in the 2021 annual report. Risk and risk management is also explained in the directors' report and the sustainability report, where both are a part of the 2021 annual report.

Outlook

Norwegian Property manages modern and flexible properties located in attractive clusters near public transport hubs. The company has delivered strong and stable results from its operations and from fair value changes for its properties over a long period.

The company has three clusters for commercial properties - Oslo CBD, Nydalen and Fornebu - in addition to the investment in the residential developer Nordr.

Norwegian Property has a strategy for growth in its core commercial property business as well as an ambition to consider opportunities in other property segments. Norwegian Property will continue its efforts to expand and develop its business through additional acquisitions and by pursuing several interesting long-term development opportunities in the existing property portfolio.

Declaration by the board of directors and the CEO

The board and the CEO have today considered and approved the directors' report for the first half of 2022 and the consolidated half-year financial statements for Norwegian Property ASA as at 30 June 2022. The consolidated financial statements for the first half have been prepared in accordance with IAS 34 Interim reporting as approved by the EU and additional Norwegian reporting requirements pursuant to the Norwegian Securities Trading Act.

To the best of the board's and the CEO's knowledge, the interim financial statements for the first half of 2022 have been prepared in accordance with the applicable accounting standards, and the information in the financial statements provides a true and fair picture of the overall assets, liabilities, financial position and financial results of the group as at 30 June 2022.

To the best of the board's and the CEO's knowledge, the directors' half-year report provides a true and fair overview of important events in the accounting period and their influence on the financial statements for the first half. Notes to the condensed financial statements

NOTE 1: General information

The Norwegian Property ASA real estate group primarily owns commercial properties in the Oslo region. Norwegian Property also owns a share (joint venture) in the residential development company Nordr. Nordr has residential units under construction and a land bank in the largest Norwegian and Swedish cities. In Stavanger, Norwegian Property has a joint venture for the development of a property with a combined residential and commercial purpose.

The holding company, Norwegian Property ASA, is a public limited company with its headquarters located at Støperigata 2, Oslo (Norway). Geveran Trading Co. Ltd. owns all the shares in Norwegian Property ASA.

The interim report of Norwegian Property ASA was approved at a board meeting on 7 July 2022. The report has not been audited.

In accordance with the requirements of section 3, subsection 3 of the Norwegian Accounting Act, Norwegian Property presents annual statements on corporate governance and social responsibility. The latest disclosures are contained in the annual report for 2021.

NOTE 2: Accounting policies

The financial statements include Norwegian Property ASA and subsidiaries. Sold properties are included in the accounts until the completion of the transactions. Acquired properties are included in the financial statements from the date of acquisition.

Management makes estimates and assumptions concerning the future. The accounting estimates will by definition seldom be fully in accordance with the final outcome. Estimates and assumptions which have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities primarily relate to the valuation of investment property.

This interim report is prepared in accordance with IAS 34 Interim Financial Reporting. The interim financial statements are prepared in accordance with the applicable IFRS standards and interpretations. The accounting policies used in preparing the interim report are in accordance with the principles applied in preparing the annual accounts for 2021. The interim report presents condensed financial statements and does not contain all the information required for full annual financial statements. The report should, therefore, be read in conjunction with the financial statements for 2021.

No significant changes have been made to accounting policies compared with the principles used in the preparation of the financial statements for 2021. Norwegian Property has not implemented any new standards or changes of standards in the 2022 interim financial statement. There are no material new standards and interpretations not yet implemented.

NOTE 3: Segment information

Commercial properties

Norwegian Property's primary business is the ownership and management of commercial properties in the Oslo region.

Residential properties

The company has an investment in the residential development company Nordr. In Stavanger, Norwegian Property has a joint venture for the development of a property with a combined residential and commercial purpose (Forusbeen 35).

Financial segment information

The segmentation of operating profit, excluding the administrative owner costs, reflects the division into commercial property and residential property segments. A similar division has also been made for all balance sheet items apart from those related to group functions, financing of the group and tax positions.

Nordr

Norwegian Property owns Nordr together with Fredensborg and Union Real Estate Fund III. While Norwegian Property and Fredensborg are equal partners with a share of 42.5 per cent of preference shares each Union own 15 per cent. Norwegian Property owns 42.4 per cent of all shares in the company. Nordr has flats under construction and a substantial land bank in Norway and Sweden. The land

bank is largely located in the largest Norwegian and Swedish cities, with an emphasis on eastern Norway and the extended Stockholm capital region in Sweden.

Forusbeen 35

The property at Forusbeen 35 in Stavanger has undergone a re-regulation from a commercial building to a property with a combined residential and commercial purpose. Norwegian Property owns the project as a joint venture together with Base Bolig.

The company's policy is to make transfers between levels at the time of the incident or circumstance which caused the transfer. No movements between the levels have occurred in 2021 and 2022.
